JANM completed the conceptual design phase of its core exhibition which will place the Japanese American story within the larger American narrative. The permanent exhibition, Common Ground, was installed over twenty years ago. Changing demographics and visitor experience as well as new technologies have made it imperative that the Museum re-imagine how it interprets and presents the Japanese American experience for today's audiences. The project which is the Museum's top programmatic priority, will include extensive renovation to the public galleries on the first floor.

During FY 21, the Education Unit developed a new virtual visit program to connect virtual student visitors and educators with Museum staff and volunteers. This included the development of pre-visit lessons, live presentation lessons, and virtual training for volunteers. The majority of visitors came through school visits from with the remainder through adult groups, including corporate audiences seeking Diversity, Equity, Accessibility, and Inclusion (DEAI) programming for their employees in response to hate and discrimination directed towards Asian Americans. A goal of this program is to use object-based learning with artifacts from the JANM collection. Engagement strategies that are used for

A bright note during JANM's closure was the launch of the new janm.org website, a significant undertaking that considerably stepped up our capacity to provide virtual experiences that educate and inspire. Already, online visitorship has increased by almost twenty five percent. JANM's marketing and communications output was considerable. It included almost 50 regularly scheduled e-newsletters and 24 press releases. Open and click-through rates for newsletters and emails about JANM From Home and from the Store, Education and Membership exceeded industry standards. The exhibition calendar was a moving target while we were closed to the  
public, with constantly adjusted timelines for fabrication/installation  
and opening dates to accommodate the uncertain duration of the COVID  
closures. We also had to plan for accommodations required for a  
socially distanced museum and their impact on the presentation of  
exhibitions. Where once exhibit interactives were a benefit, they now  
posed serious health risks. The immersive exhibit experience, *Life in  
Pieces: The Diary and Letters of Stanley Hayami*, for example, was  
migrated from a virtual reality format which was wholly dependent on  
shared headsets and devices to a WBXR format to make it safely  
accessible on personal handheld devices and laptops. The virtual  
reality video debuted at the Tribeca Film Festival in New York in June  
and the exhibition itself opened at JANM early in FY22.

The Collections staff created new online content including nine videos  
for the Unboxed series, and 13 videos for JANM's social media. They  
also gave presentations and created seven videos for virtual  
programming including the *Tadaima* virtual pilgrimage and the series,  
*Taste of Home*.

JANM also responded to 201 artifact donation offers, and presented 54

donation offers (ten from a backlog) to the collections task force and board of trustees for acquisition, and arranged for delivery of accepted artifacts.

in-gallery experiences were transferred to the virtual environment to maintain interactivity and dialogue.

In addition to groups from California, virtual visitors were from 13 states and the District of Columbia, and Japan, Canada, and Spain. To promote it to educators, a virtual visit introduction preview for educators was conducted online, and JANM served on a panel with the Chinese American Museum and the Pacific Asia Museum for the Alliance of Asian Pacific Administrators. JANM was also a content provider for the Center for Interactive Learning and Collaboration website. Due to the success of the virtual visits, JANM is committed to continuing them beyond the pandemic to serve audiences further afield who are not physically able to visit the Museum.

Several online resources were also created in FY 21 for the new JANM from Home program, including printable activities inspired by the collection, and new video lessons and activities. An orientation video was created by the Watase Media Arts Center (MAC) to introduce educators to educational resources on the new website. Video recordings of hands-on activities were created and published online by MAC for the Tadaima virtual pilgrimage, and JANM's virtual Oshogatsu.

Many collaborative programs were done with the Smithsonian Institution

in FY21. JANM served as a regional host for the Smithsonian's virtual National Youth Summit, Teen Resistance to Systemic Racism, and JANM worked with the Smithsonian Affiliations to plan A Legacy of Healing, Rebirth, and Leadership as part of the Smithsonian Affiliation Virtual Scholar Talk series. Additionally, activity kits (with supplies and printed activities from JANM, La Plaza de Cultura y Artes, and the Smithsonian) were distributed to youth in downtown Los Angeles through the YMCA and Little Tokyo Service Center.

Work began on the HALO award given in November 2020 by the Carl and Roberta Deutsch Foundation. This year-long process will include peer learning and one-on-one coaching sessions to reinvigorate the volunteer program and develop a volunteer management plan that is fit for purpose. The JANM team is made up of staff representatives from the Education Unit and Volunteer Office as well as a museum volunteer.

Form 990, Part III, Line 4c, Program Service Accomplishments:  
including Instagram, Twitter, Facebook, YouTube, grew considerably as did JANM's virtual national and global visitorship. The growth is attributable to several factors including a Google Ads Grant that awards JANM \$10,000 a month to drive search ads coupled with dedicated staff who have increased daily social media postings.

The team also leverages cross promotions to highlight JANM and introduce the Museum to new audiences. These included a partnership with Made By Us, a Smithsonian-led initiative to engage with younger audiences through social media engagement content and joint virtual public programs; with PBS to include JANM staff and volunteers as

participants in a documentary series, PBS American Portrait, a crowdsourced, storytelling project about what it means to be American today that aired on all PBS stations in January 2021; with The 2020 Project to register 100,000 Asian American and Pacific Islanders to vote by providing public education and a virtual space for civic engagement on the local, regional, and national scale; with Gold House to encourage participation in the 2020 census; and with USPS in a shared collateral social media campaign for the launch of the Ruth Asawa series of Forever stamps.

Public Programs presented over 75 programs, of which 60 were virtual programs during COVID closures. These included a collaboration with the National Park Service and the Japanese American Memorial Pilgrimages (JAMP) that gathered representatives from many different sectors of the Nikkei community, as well as scholars, artists, and educators committed to memorializing the history of Japanese American WWII incarceration; Looking Like the Enemy: Race and the Legacy of the Vietnam War with the Asia Society; They Called Us Enemy: An Intergenerational Conversation on Racial Injustice in partnership with LA Public Library and the Koreatown Youth and Community Center; and Building and Bridging, co-presented with the Consulate General of Japan in Los Angeles & the Japan Business Association of Southern California. JANM also hosted the Japanese American Confinement Sites Consortium (JACSC) in October for the first virtual JACSC education conference. The free conference included educational sessions and conversations with national thought leaders and experts on Japanese American history and its continued relevance today.

Museum attendance was greatly impacted by its pandemic closure starting

March 2020. For FY 21, the Museum had no visitors from July 1, 2020 through April 15, 2021. The Museum reopened on April 16, 2021 initially with limited weekend ticketing, and in June, reinstated a return to pre-pandemic opening hours.

The JANM Store continued its COVID closure during FY 21, but it set new online sales and promotions records despite the shuttering of its bricks-and-mortar outlet. Overall, Store goals for FY 21 were either met or surpassed, with sales twenty three percent higher over the prior year. Several new marketing strategies accounted for the surge in sales. By following the buying trends (home dcor, civil rights resources, cultural diversity products, enlightening gifts to educate and occupy children, cooking, etc.) JANM refreshed and complemented current inventory. The Store debuted a 32-page catalog in print and digital format, the largest produced in 21 years, with a record 23 proprietary products. The JANM exclusive products also included partnerships with artists who have global fan followings and cross-promotions with public programs.
